Potato steam peels Waasten are made by peeling the potatoes in a steam process. This creates a mass of protein, starch and crude fiber after 'steam peeling'. The starch present is very digestible as a result of the steam treatment. The product complies with laws and regulations. Mycotoxins, insecticides, pesticides and herbicides are tested according to the GMP+ FSA. The product is non-GMO (according to Regulation (EC) 1829/2003 and 1830/2003).
